RELEASE OF LIABILITY AGREEMENT, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

PLEASE READ CAREFULLY!

I understand that I am not permitted to participate in YMCA programs, services, and facilities unless I sign this agreement.

In consideration of being permitted to participate in YMCA programs, services, and facilities (herein after called the "YMCA Programs"), I hereby release and forever discharge the YMCA of Simcoe/Muskoka ("YMCA") and their administrators, agents, officers, board members, volunteers, and employees, other participants, any sponsors, and if applicable, owners and lessors of the premises (the "Releasees"), from any and all claims against for or by reason of any injury to person or property, including injury resulting in disability, paralysis or death, which has been or may be sustained as a consequence of my participation in YMCA Programs and notwithstanding that such damage, loss or injury may have been caused solely or partly by the negligence of the YMCA.

I understand that participant rules will be provided for my safety and I agree to abide by them. I recognize and understand those rules will not and do not eliminate risk of harm to me and I hereby acknowledge and agree that participation in YMCA Programs comes with inherent risks. I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation and that I am voluntarily assuming said risks, including but in no way limited to: injuries from physical exertion; injuries caused by my action or inaction, program equipment or structures, buildings; changing weather conditions; changes or variations in the terrain; slips, trips, and falls; encounters with nature including toxic plants and animals; failure to stay within my own ability; injuries related to water-based activities; negligence or the acts or omissions of other participants; SARS-CoV-2 and COVID-19 and other infectious or communicable diseases and viruses.

I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which any may incur as the result of such claim. I further agree not to make any claim or take any proceedings against any other person, individual, partnership, association, trust, unincorporated organization or corporation ("Third Parties") who may claim contribution or indemnity or other relief over from the YMCA.

I further agree to indemnify and reimburse the YMCA for any legal costs (on a solicitor-client basis) and disbursements and taxes incurred by the YMCA in defending or prosecuting any proceedings contemplated or referenced above or otherwise arising from this agreement.

If any part of this agreement is deemed to be invalid or unenforceable, the remainder of this agreement shall not be affected, and each term and condition of the agreement shall be separately valid and enforceable.

I hereby acknowledge and agree that I have carefully read this agreement and fully understand the contents of this agreement, and am freely and voluntarily executing same.
